What is the Long-term Plan?

The Long-term Plan sets out the Council's priorities. It includes detailed information on the activities, services, and projects we intend to deliver, and therefore what the proposed rates and debt will be for the next 10 years.

It costs over a billion dollars each year to run Wellington City. We collect this money through rates, fees and charges, development contributions, grants and borrowing.

With input from the community, we need to decide how much we'll spend on what, and what level of rates to set, so every three years we update our Long-term Plan.

How does the planning process work?

The final Long-term Plan is approved by the Mayor and Councillors following 18 months of work and public engagement.

After each phase of engagement, Councillors review the public's feedback and use it to make their decisions at each stage of building the plan. They will make their final decision about what is or isn't in the plan in May 2024.

The final plan is due to be adopted by Council by the end of June 2024 and will then be available on our website from July 2024.

The 2024–34 Long-term Plan will come into force on 1 July 2024 and will direct our work and expenditure until the next review in 2027.

Community engagement timeline

April-May 2023

Outcomes and Priorities

More than 3000 Wellingtonians shared their priorities for the city over the next 10 years by completing an online survey or attending a public workshop.

September-October 2023

Citizens' Assembly

The Citizens' Assembly – a randomly selected group of 40 people representing Wellington's diverse population – gave a collective view about which Council services should be prioritised over the next 10 years.

Rating Policy Review

We consulted on the review of our rating policies, which looked at how the overall rates bill is divided up - that is, the proportion each property owner pays.

April-May 2024

Formal consultation

Formal consultation, where people can provide submissions on the proposed Long-term Plan, is open from 12 April to 12 May.

May 2024

Oral submissions

After the close of the formal consultation, people can speak to their submissions in front of the Mayor and Councillors at an oral hearing.

What happens next?

The Mayor and Councillors are given copies of all submissions. We also prepare reports on the submissions, so Councillors know how many there were and what the main themes and comments are. If you wish to speak to your submission in front of the Mayor and Councillors at an oral hearing, you can indicate this on the submission form.
